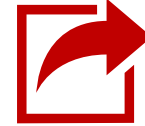
- Presented as part of the 2023 AGM, the completed 2022 Annual Report provides complete details on AMCTO activity

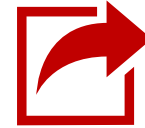

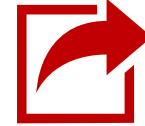

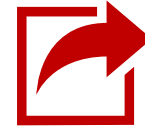
