1. Welcome & Call to Order

2. MPAC Updates – What's New, What You Should Know

Kaitlyn Potts, Account Manager and Sarah Groves, Account Manager, provided MPAC updates to the Zone regarding modernization initiatives, building related assessment growth, use of the assessment roll books, school board registration portal, homeownership hub and auditor requests.

10. AMCTO Updates

Elana Arthurs, Immediate Past President of AMCTO and Ya-Yin Ko, AMCTO Manager of Education Services provided updates on the:

- latest policy initiatives
- financials and membership numbers
- website upgrades including Zone connections

Members requested information regarding years of service certificates, policy advocacy for the Line Fences Act and central options for the circulation of Ontario wide resolutions.

11. Conduct at Council Meetings – The Good & The Bad

John Pappas, legal counsel from Aird & Berlis, provided case law updates related to the behaviours of the public at Council meetings or around municipal administration facilities and provided information regarding enforcing decorum and strategies to deal with difficult people.

12. Protect Your Municipality – Practical Risk Management Techniques

Jolene Ingribelli from BFL provided information on how municipalities could lower their risk including reviewing claims – current and historical, updated policies and procedures, insurance for third-party and community groups, and staff roles in risk management.

13. Sponsor Presentation – The Managed Municipality

Silvanus Santhosh, from the Managed Municipality, provided an overview of his firm's services including a demonstration on the cemetery management platform.

14. Multi-Year Budgeting & Pre-Tendering

Jennifer Stover from the County of Peterborough provided a presentation regarding long-range financial planning including planning post-terms, holistic financial planning, stabilizing tax levy increases and the impact of assessment growth. Information was provided regarding pre-tendering including human resources planning, reserve and debt strategies, and general planning ideologies.

15. Lights, Camera, Action – Hollywood in Your Backyard

Andrew Sorlie from Stature Films provided information regarding the film industry's production and site location process highlighting the value of a fulsome inventory of known municipal sites, barriers of support infrastructure including accommodations and opportunities for collaboration with willing municipalities for future film productions in their communities.
