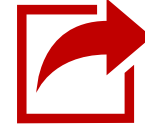

## Accomplishments

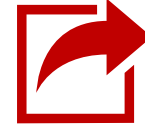
### New Members (As of August 31)

Since September 1, 2023, there has been a total of **395 new members** joining the association.

- Up from 282 during the same period last year

### Membership Growth Continues

- **Active members:**
  - August 31, 2024 – **2,254**
  - August 31, 2023 – **2,152**
  - August 31, 2022 – **2,070**



## Recent & Ongoing Work

### New Member Promotion

- Half-price membership for first year of Association membership (remainder of 2024 + all of 2025) offered to all non-members enrolled in Fall 2024 education and professional development programs
- Resulted in **22 new members** so far (as of September)

### AMCTO “Road Shows”

- Promoting AMCTO membership, programs and services in identified municipalities with lower membership representation
  - City of Waterloo – October 2
  - City of Brampton – October 3
- Will review results with possibly more road show dates in 2025

### Mentorship Program

- 65 matches, up from 45 last year

### AMO Conference Delegations

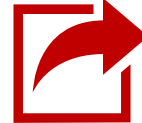
- Successful AMO conference delegations with Ministries of PBSDP, NDP, and Green Parties

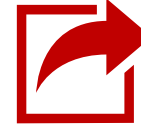

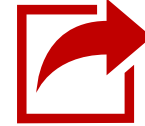

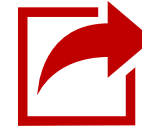
